**Re: DACA, DREAMERS Effect on American Black U.S. Citizens**

We, the National Conservancy for the preservation of U. S. Black citizens are a volunteer humanitarian entity that transcends the political, ethno-racial, cultural, religious, etc. sectors of society with the specific purpose to:

...**inform, enlighten and teach** U. S. citizens of all ages and ethnicities, but specifically every black citizen (i.e., the descendants of chattel slaves of African descent), the original intent of the **14<sup>th</sup> Amendment – 1866 Civil Rights Act**, which is *solely our* official, National Identity, Birth, and Civil Rights Certificate.

...**that we, collectively**, may be empowered to conserve, preserve and promulgate the Constitutional mandate authorizing black citizens with a special citizenship status experience, “as is enjoyed by white citizens”, directly under the jurisdiction of the federal government and executed by the President as Commander in Chief of the armed forces...

As you have rightly proclaimed that “illegal immigration” hurts black citizens more than anybody else, we are morally compelled to support you in your efforts on the matter of DACA, immigration (illegal and legal) as it critically relates to U. S. black citizens; and we look to you as our ancestors did to POTUS Abraham Lincoln, who you courageously and correctly, seek to emulate, if not do greater than the great emancipator.
