Dear Attorney General:

We, the National Conservancy for the Preservation of American U. S. Black Citizens, are in great support of your DACA (Deferred Action for Childhood Arrivals) letter to U. S. Attorney General Jeff Sessions.

In it you are requesting that the presidential memo issued by the Honorable Barack H. Obama, which illegally implemented the DACA programs, be ended by Tuesday, September 5, 2017.

The National Conservancy is a volunteer humanitarian entity that transcends the political, ethno-racial, cultural, religious, etc., sectors of society, with the specific purpose to:

**...inform, enlighten and teach** U. S. citizens of all ages and ethnicities, but specifically every black citizen (i.e., the descendants of chattel slaves of African descent), the original intent of the **14<sup>th</sup> Amendment – 1866 Civil Rights Act**, which is *solely our* official, National Identity, Birth, and Civil Rights Certificate.

**...that we, collectively**, may be empowered to conserve, preserve and promulgate the Constitutional mandate authorizing to black citizens with a special citizenship status experience, “as is enjoyed by white citizens”, directly under the jurisdiction of the federal government and executed by the President as Commander in Chief of the armed forces...

Knowing for decades the above to be true, we concur with the Honorable President Donald J. Trump who correctly proclaims that “illegal immigration” hurts black citizens more than anybody else, we are morally compelled to support you in your efforts on the matter of DACA as it critically relates to U. S. black citizens.

Yet, during the decades of debate around the nation-threatening matter, black citizens have been summarily excluded. It’s as though they/we don’t exist. We are proud of your efforts in defending the U. S. Constitution, and honored to support them, giving thanks to GOD for your dutiful leadership.
